enable the selection committee to prepare merit list which is prepared on the basis of marks secured.

2. Age Limit

The maximum age limit for the candidates belongs to all candidates belongs to all categories except SC/ST is 23 years for first year and 25 years for direct 2nd year. In respect of SC/ST candidates the maximum age limit is 25 years for 1st Year and 27 Years for direct 2nd year as on 1st July 2024.

3. Stipend

Each Student admitted into the course, both to I year and II year under lateral entry will be eligible for a monthly Stipend of Rs.2500 to be paid 50% by Central Govt. and 50 % by State Govt. as per the guidelines, for the duration of the course (tenable for 10 months per annum).

4. Reservation

Reservation will be as per the UT Govt. Policy. In addition, a minimum 20% of total seats allotted to the UT are reserved for the candidates belonging to weaver Community.

Shortfall, if any will be met out from the candidates other than those belonging to the weaver's community.
