As per the approval conveyed by Administrative Department (Industries and Commerce) vide letter No. IC-HHD/23/2023-02 dated 29-12-2023, Sanction is hereby accorded to the temporary appointment of **Mr. Jugraj Singh S/o Late Ravi Singh, Ex-MTS, R/o Madoon Tehsil Rajpura, District Samba** as Class -IV(MTS) in the Pay Level of **SL-1 (14800-47100)** against an available vacancy in the office of Assistant Director, Handloom, Samba, in terms of J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 of 1994 dated 22-02-1994.

The appointee shall report to the Assistant Director Handloom, Samba, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on the production of the following documents/ certificates(in Original) to be verified subsequently by the concerned DDO:-

1. Academic Qualification certificate(s).
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned Chief Medical Officer of the district.
5. Dependent Certificate issued by the competent authority.
6. No loan certificate issued under Self Employment Scheme from DIC concerned and Employment Department, if required.
7. Category Certificate, if any.
8. Any other relevant document(s) as required under rule.



The appointment of the appointee shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an affidavit to the effect that if on verification, genuineness of his qualification certificates from the concerned issuing authority is found fake/ forged, the claim of the appointee for appointment as Class -IV (MTS) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of qualification / date of Birth and other relevant certificates required under appointment of SRO 43 are received from the concerned authority/ agency in his favour.
- c. The appointee shall be initially on probation for a period of two years.
- d. The appointment shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009.
- e. If the appointee fails to join within a period of 21 (Twenty One) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- f. The appointment of the said appointee shall be subject to outcome of writ petition, if any, pending before competent Court of Law.
