The appointment of the appointee shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an affidavit to the effect that if on verification, genuineness of his qualification certificates from the concerned issuing authority is found fake/ forged, the claim of the appointee for appointment as Class –IV (MTS) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of qualification / date of Birth and other relevant certificates required under appointment of SRO 43 are received from the concerned authority/ agency in his favour.
- c. The appointee shall be initially on probation for a period of two years.
- d. The appointment shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009.
- e. If the appointee fails to join within a period of 21 (Twenty One) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
